For Property known as 235 Edison Road-Submitted by Codespoti & Associates for property owner TMC Orange, LLC. Application was submitted on May 7, 2019. The subject property is 235 Edison Road. The proposal is for the 19,020 Sq. Ft. expansion of an existing industrial/manufacturing facility and the relocation of the attendant parking and loading areas. Such work includes regarding, paving, wall construction and modification of existing stormwater detention structure. The 100-foot upland review area is comprised of approximately 45,781 Sq. Ft., and the on-site wetlands contains approximately 18,545 Sq. Ft., comprised of two segments. The naturally formed wetlands/stream contain approximately 14,714 Sq. Ft. and manmade detention pond, approximately 3,631 Sq. Ft. The proposed activities will impact 33,458 Sq. Ft. Review Area and the entirety of the 3,631 Sq. Ft. Storm Water Detention Facility.
