The purpose of the meeting was: Executive Session, Conn. Gen. Stat. Sec. 1-200(6): Discussion concerning employment, performance, health, and request for a Duty Injury Disability Retirement by Officer James Kline.

The Board invited Chief Gagne into the Executive Session at 5:40 pm. The Board invited Officer Ahern into the Executive Session. Chief Gagne left the meeting to retrieve Officer Ahern. Chief Gagne and Officer Ahern entered the Executive Session at 5:48pm.

The Board came out of Executive Session at 5:53 pm. The public meeting session resumed at 5:54 pm. All Board members, Chief Gagne, Officer Ahern, Assistant Chief Martins, and Board Secretary Canapinno attended the resumption of the public meeting session.

Commissioner Carveth made a motion to deny the application of Officer Kline to receive a disability pension based on contractual language between the Town of Orange and the UPSEU/COPS Labor Union, pursuant to the contract dated 7/1/2016 through 6/30/2019; the contractual language contained within does not support Officer Kline's application. Commissioner Cuzzocreo seconded. **Motion passed unanimously.**

Commissioner Grasso, seconded by Commissioner Carveth, made a motion to adjourn the meeting at 5:55 pm. **Motion passed unanimously.**
